### **NOTICE OF PROPOSED DISTRIBUTION**

Pursuant to Rule 175 of the Rules, NOTICE IS HEREBY GIVEN that Steven Edward Butt, the Special Administrator, proposes to make a fourth and final distribution to the unsecured creditors of the Company.

The last date for proving debts against the Company is, 22nd JANUARY 2026 by which date claims must be sent to the undersigned, of Menzies LL, 4<sup>th</sup> Floor, 95 Gresham Steet, London, EC2V 7AB, United Kingdom, the Special Administrator of the Company. The distribution is being made from the available funds other than the Prescribed Part.
